NARRATIVE

ON THE DATE OF NOVEMBER 13, 2009 AT APPROXIMATELY 01:30 AM HOURS. I OFFICER DHALIWAL RESPONDED TO THE LOCATION OF MAYSON ST AND PLASTERS AVE ON A DISPUTE CALL. UPON MY ARRIVAL AT THE LOCATION, I WAS MET BY THE CALLER MR. MERION POWERS. HE STATED THAT ON THIS DATE THAT HE WAS PHYSICALLY ASSAULTED BY MR. MICAH "KAT" WILLIAMS, WHILE HE WAS AT THE FOUR SEASONS HOTEL. MR. POWERS SAID THE INCIDENT STARTED WHEN HE ARRIVED AT THE LOCATION AT OR ABOUT 09:30 PM HOURS ON NOVEMBER 12. HE STATED THAT MR. WILLIAM'S INVITED HIM OVER TO COLLECT THE MONEY THAT HE OWED HIM. UPON FURTHER CONVERSATION, MR. WILLIAM'S HAD HEARD THAT MR. POWERS MAY HAVE WANTED TO PRESS CHARGES AGAINST MR. WILLIAMS BECAUSE OF AN ALTERCATION IN WHICH MR. POWER'S DOG WAS PHYSICALLY ATTACKED BY MR. WILLIAM'S DOG ON A PREVIOUS DATE. MR. POWERS DID PHYSICALLY SHOW ME THE INJURIES SUSTAINED TO HIS DOG SAMPSON. UPON MR. WILLIAMS BECOMING AGITATED AT THE LOCATION, MR. POWERS GIRLFRIEND WAS INSIDE OF THE HOTEL ROOM TO WITNESS THE EVENT'S WHICH TOOK PLACE ON THIS EVENING. SENSING THAT AN ALTERCATION WAS ABOUT TO TAKE PLACE MR. POWERS TURNED HIS AUDIO RECORDING ON FOR HIS CELL PHONE AND RECORDED CONVERSATION AND INCIDENT THAT TOOK PLACE ON THIS EVENING. MR. WILLIAM'S WAS ON AUDIO RECORDING STATING THAT HE DID PHYSICALLY STRIKE MR. POWER'S ONCE IN THE NOSE. A PHYSICAL STRUGGLE WAS APPARENT BY LISTENING TO THE AUDIO RECORDING ON THIS DATE. MR. POWER'S NOSE DID SHOW SIGNS OF SWELLING AT TIME OF PRELIMINARY REPORT AND HE DID REFUSE EMS ON THIS DATE. UPON MR. POWER'S BEING STRUCK BY MR. WILLIAM'S HE WAS HELD BACK BY MR. WILLIAM'S BODY GUARDS AT THE LOCATION WHICH PLACED HIM IN A HOLD IN WHICH HE COULD NOT GET FREE. STRUGGLE WAS CAUGHT ON AUDIO TAPE. UPON MR. POWER'S GIRLFRIEND LEAVING THE ROOM OF ALTERCATION, SHE CALLED HOTEL SECURITY TO ROOM AT WHICH TIME MR. POWERS WAS ABLE TO LEAVE THE HOTEL ROOM. MR. POWER'S FELT INTIMIDATED BY SECURITY AT THE LOCATION, BECAUSE THEY WERE BLOCKING HIS AVE OF EXIT FROM THE ROOM. MR. POWER'S ADVISED OF SERVICES OF FULTON COUNTY COURTHOUSE TO OBTAIN WARRANT. NO FURTHER INCIDENT REPORTED TO OFFICER ON THIS DATE AND TIME.
