

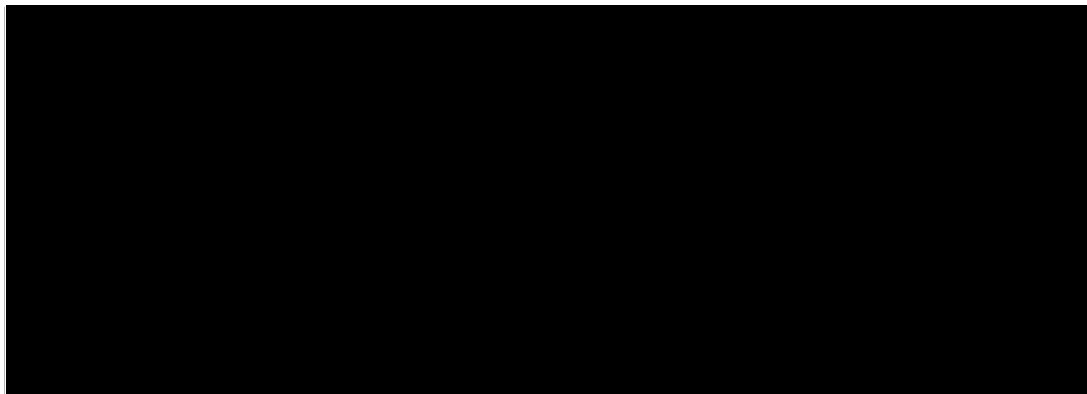
SEARCH WARRANT

To: All Peace Officers of the State of Georgia

The Undersigned Agent Jonathan Fincher, being duly sworn, deposes and says that I am an agent of the Henry County Police Department, charged with enforcing the criminal laws of this state, and I have reason to believe that on the person or property described as follows: the entire premises, cartilage, vehicles and persons located at [REDACTED]

[REDACTED] The dwelling is in primary control of Juaquin Malphurs AKA "Waka Flocka". The dwelling is a two story residence with a split level basement, beige in color stucco on four sides and white trim. The roof is comprised of grey and black shingles. There are two red brick steps leading to a glass screen front door. Behind the glass screen door is a brown door with several glass panes. There are three white garage doors off the driveway to the left of the residence. There is a concrete driveway to the left side of the residence. There is a black mailbox to the right of the driveway with a black post. The numbers 103 in white numbers are displayed on top of the mailbox.


There is now located certain instruments, articles, or things, namely **marijuana, articles, pictures, and communications relating to gangs and gang paraphernalia which is being possessed in violation of Georgia Laws O.C.G.A 16-13-30 and 16-15-4.**


Based on the affidavit given under oath or affirmation and all other evidence given to me under oath or affirmation, I am satisfied that there is probable cause to believe that a crime is being or has been committed and the illegal contraband described above is presently located on the person(s), premises, or property described above as well as any people and/or vehicles that may arrive prior to or during the execution of this Search Warrant.

You are hereby commanded to enter, search, and seize within (10) days of this date, the person or premises or illegal contraband described above. A copy of this search warrant is to be left with the person searched, or if no person is available, on the premises or vehicle searched, and a written return, including an inventory of any things seized shall be made before me or a Court of competent jurisdiction without unnecessary delay after the execution of this Search Warrant.
